#### SCREDINGTON PARISH COUNCIL

Minutes of the meeting of the Parish Council held in the Community Centre Tuesday, 10 December 2019

#### 1.0 Welcome remarks by Chairman

Chair welcomed all present and informed the meeting of the recruitment procedure for the vacant Parish Councillor's position. The last date for 10 or more residents to call an election is December 31. After this date the Council can co-opt.

Three members of the public present. The Chairman opened the public forum at 7.32pm

A resident expressed his disgust at the state of the road on Main Street, near Drove Barn, and asked what the Council was going to do. The Chairman explained Highways had been informed on several occasions but would again report the fault, and copy in the Member of Parliament, for the district, when known. The Clerk stated as there is no hard kerb, for tarmac to be butted up against, it is difficult to resolve the problem.

Cllr Hagues stated he would take this up with Highways. He informed the meeting if any motorist incurs damage to their vehicle, due to potholes, to take photographic evidence and send this with any claim.

All residents are reminded highway faults can be reported via the FixMyStreet app on LCC's website.
