Cllr A Hagues reported the eastern bypass for Lincoln was now back on track.

- 8.3 The 30mph sign at Drovers Barn has not been replaced. Clerk to report to Highways.
- 8.4 An update on the provision of HGV signs for Northbeck is still ongoing. Heritage England may be able to have bollards placed near the Packhorse Bridge.
- 8.5 Other issues:
 - 8.5.1 Footpaths from the bridge on Station Road round to Mareham Lane and Main Street to Northbeck need cutting. Clerk to contact Highways.
- 8.5.2 Residents present informed Council the side of the bridge on Station Road needs repairing. Clerk to contact Highways.

A letter of thanks has been sent to Highways thanking them for the work carried out on Gorse Drove.
